1. Report Summary:

- 1.1. This report details a change to the Security of Employment and Redundancy Policy the change concerns how to calculate redundancy payments.

2. Background:

- 2.1. Paragraph 12.3.1 of the Security of Employment and Redundancy Policy shows that statutory redundancy pay (Appendix A) is multiplied by 4 when calculating redundancy pay for SCC. Therefore SCC's multiplier is 4.
- 2.2. In August 2016, South West Councils produced a survey identifying the multiplier used by other Councils this is shown at Appendix B.
- 2.3. It can be seen that Salisbury City Council's multiplier of 4 is in excess of any other Council shown in the survey.
- 2.4. There are no planned redundancies in the foreseeable future so it would seem an appropriate time to consider this multiplier.
- 2.5. To amend the policy Salisbury City Council should consult Unions and Staff, and give consideration to feedback gathered.

3. Recommendation:

It is recommended that the Committee:

- 3.1. Determine whether the multiplier is to be changed, and if so determines the level of multiplier that they wish the HR Manager to consult the Unions and staff upon.
- 3.2. Instruct HR Manager to report the findings of this consultation to this committee for their consideration in due course.
