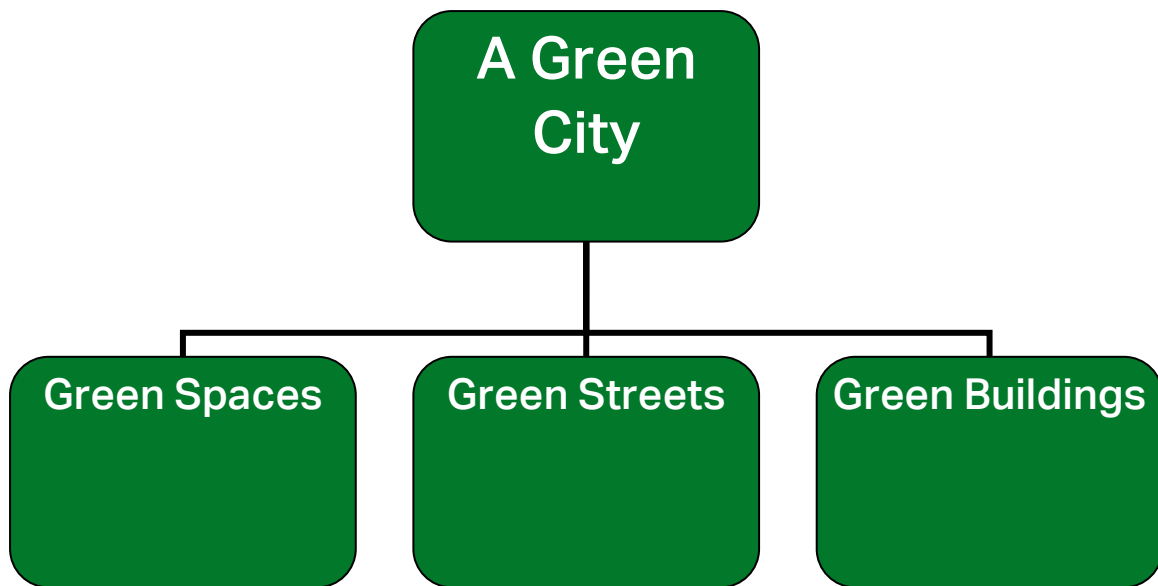

Green Spaces

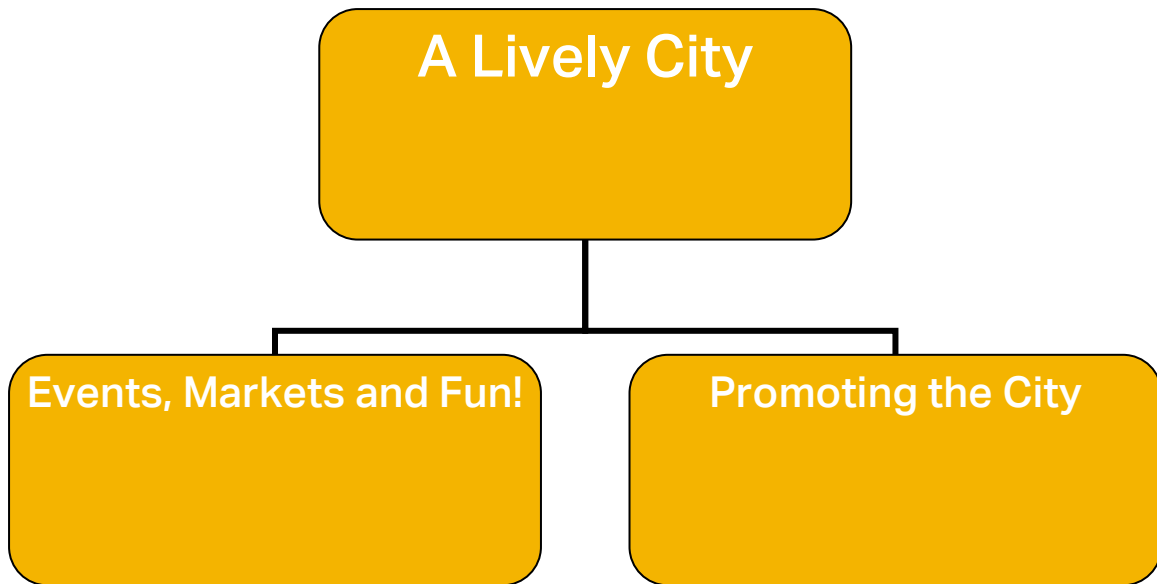
- Tree Strategy for the city

- Explore loan opportunities to support community enterprises to adopt sustainability technologies



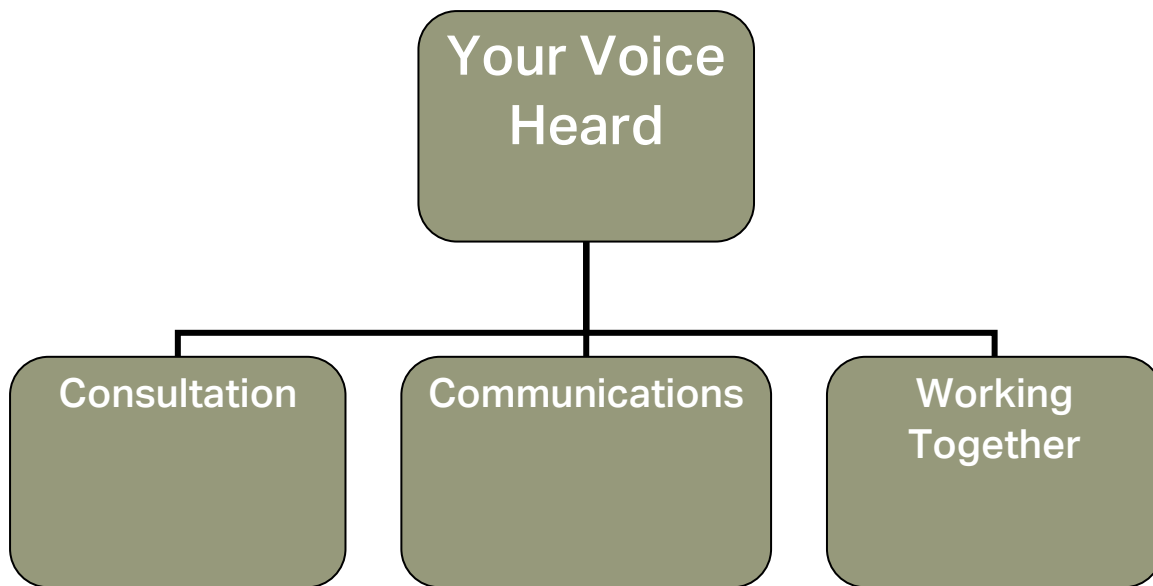

Consultation

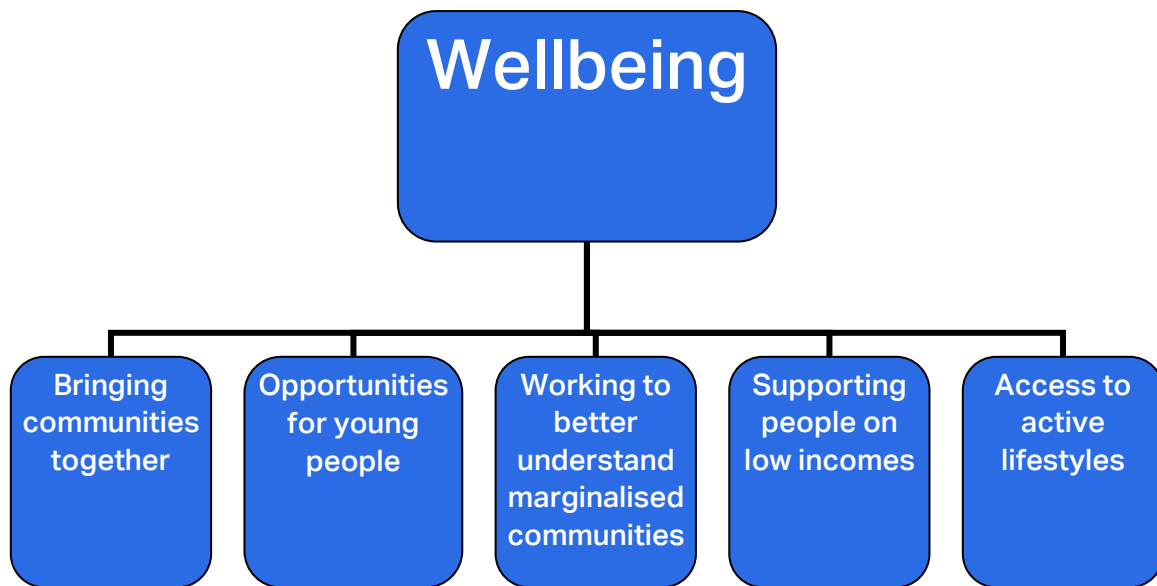
- Improve how we consult with the community to establish people's aspirations for the future, actively supporting good ideas and encouraging local initiatives

- Support members of the community to create their own initiatives and projects, through grants, advice and space



We will place wellbeing at the heart of our communities work, striving to understand mental health and wellbeing needs across the city and to develop resources to respond to those needs. We will work with community assets to ensure our work has the right wellbeing impacts and enable the community to take a lead on aspects of our work as we develop and asset based community development approach. We will measure the wellbeing impacts of all of our community activity.

Bringing communities together

- Increase participation of local residents in community projects, building community spirit and resilience
- Continue to deliver social and cultural events across the city that bring people together in celebration
- Actively support the engagement of people who experience barriers to participation in our social and cultural events
- Improve our capacity and the skills of volunteers by offering a range of opportunities and pathways for development

Opportunities for young people

- Support improved and strategic networking of youth provision across the city e.g. by working with the Area Board & Community Engagement Manager
- Include the voices of young people in our processes to identify their needs through youth survey work
- Create and support personal development, leisure and social activities for young people

- Work with others to improve access to provision and opportunity for young people – for example, to develop opportunities at The Bunker

Working to better understand marginalised communities

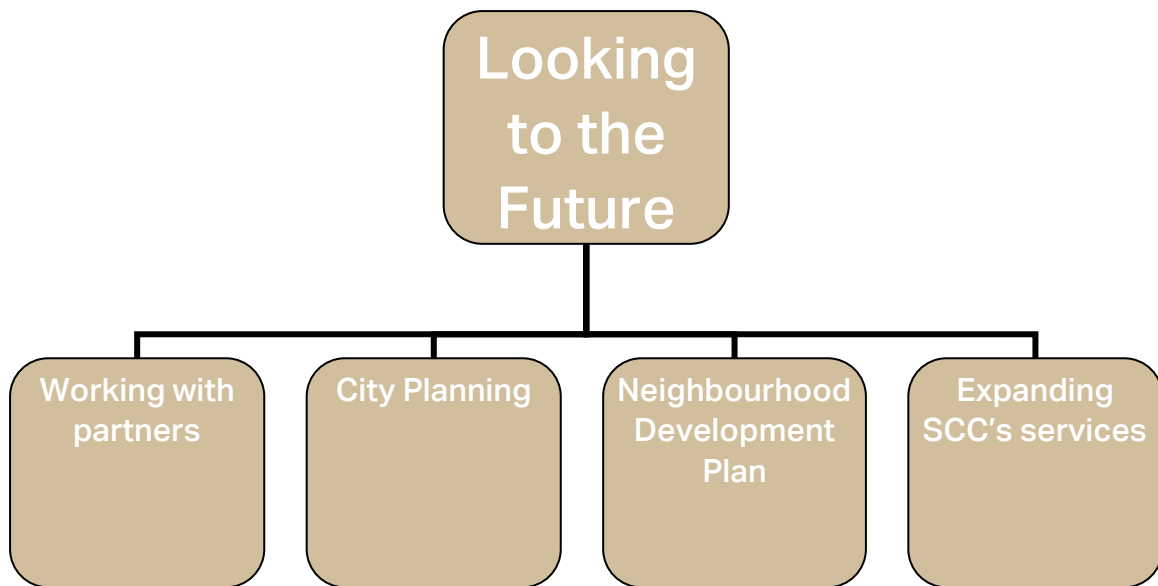
- Deliver the Friary Wiltshire Community Foundation Stronger Families project
- Connect with marginalised communities through key community assets and identify opportunities for consultation and partnership

Supporting people on low incomes

- Support and invest in Your Salisbury Pantry
- Continue to offer a programme of community activity that is financially accessible and targeted at the needs of people on low incomes
- Include the voices of people on low incomes across the city in the planning of the communities programme by continuing to work with interagency groups

Access to active lifestyles

- Support residents to lead active lifestyles, particularly those who are not currently active
- Support further development of the Sports Forum in Salisbury
- Work to improve the range, location and accessibility of physical activity opportunities across the city



We will show leadership to ensure that Salisbury is a great place in the future, and will speak out on behalf of residents so Salisbury's voice is heard

Working with Partners

- Show authority, leadership and engagement at the Future Salisbury Place Board
- Work with Wiltshire Council, the Environment Agency and others to deliver the River Park in the centre of the city
- Work with Wiltshire to deliver the High Street Fund Bid projects
- Commit to greater partnership work across the city where possible

City Planning

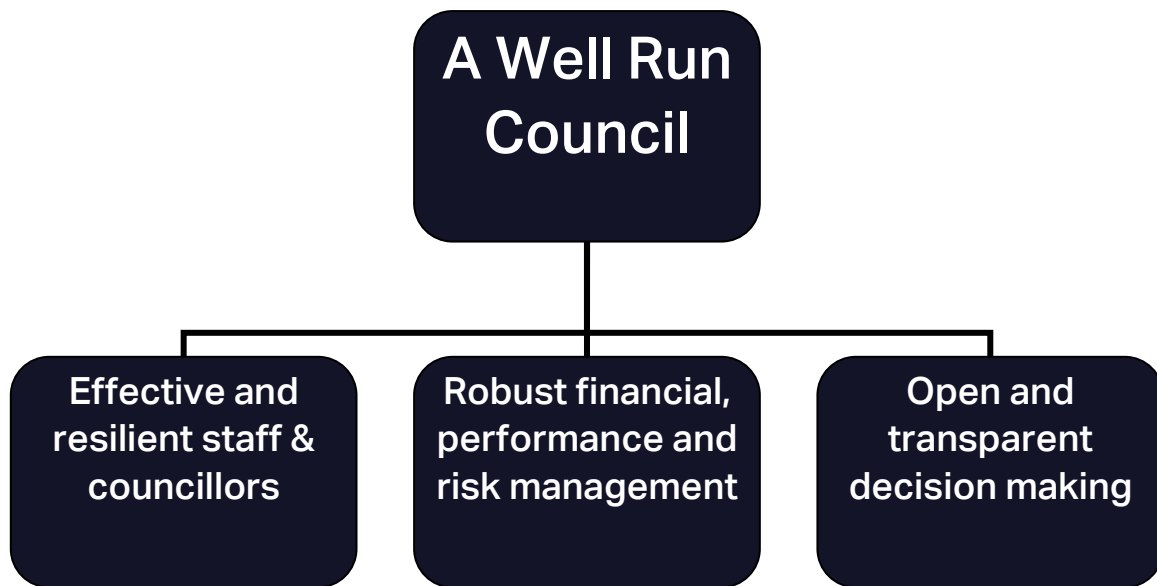
- Campaign to preserve the character of the city
