- Lease ends on Addex road sweeper so machine will be replaced with a newer model.


























CREMATORIUM TECHNICIANS TRAINING SCHEME (CTTS) BTEC Accredited

The Crematorium Technicians Training Scheme (CTTS) is provided as part of the Institute of Cemetery and Crematorium Management (ICCM) portfolio of **accredited** educational courses; it can be completed on its own to conform with the requirements of the Process Guidance Notes for Crematoria or as a prelude to the Provision Layout and Management of Crematoria Unit which is part of the ICCM diploma course.

Edexcel has accredited the course to BTEC standard and validates its contents on an annual basis. The course, which is supplied via email, is worked through at the candidate's own pace. An on site or on-line video assessment forms part of the course.

CTTS is the only qualification mentioned in the Secretary of State's Process Guidance Note that has the credibility of performing to a nationally recognised standard.

Salisbury City Council CCTV Report 2023

Key Statistics

1,169 Operator Sessions

•CCTV operators completed 1,169 shifts, averaging 97 monthly shifts across various time slots.

• 4,700 Hours Worked

•The highest recorded total since 2018, with 70% of the hours covered by volunteers.

334 Requests to View (RTV) Received
Requests were related to robbery, sexual assault, burglary, theft, rape, and criminal damage.
231 RTVs (69%) were used as evidence with a positive outcome.

1,848 Logbook Entries

•Operators recorded daily activities, responding to incidents either proactively or based on information from partners.

Summary of Salisbury City CCTV Report 2024

Key Points

1,089 operator sessions – CCTV operators carried out
 1,089 duties, averaging 91 shifts per month across day,
 evening, and overnight.

 4,815 hours worked – An increase of 115 hours compared to 2023, continuing a four-year upward trend.

 30 different operators – A team of 27 volunteers contributed 76% of total hours in the control room.

 408 RTVs received – These requests were related to theft, robbery, fraud, assault, burglary, and other crimes.
 271 of these were seized as evidence.

 2,127 logbook entries – CCTV operators documented daily incidents, either in response to alerts or through proactive observation. Top crime categories for RTVs in 2024:

Assault (84 cases)
Theft (63 cases)
Criminal damage (48 cases)
Burglary (23 cases)
Public order offenses (20 cases)

 RTV and evidence trends - Over the past four years, the percentage of RTVs leading to evidence seizure has stayed around 65-69%.

The CCTV team plays a **critical role** in monitoring and documenting incidents, assisting law enforcement, and maintaining public safety.

Key Observations

Increased Hours Worked - 115 more hours logged in 2024, continuing a four-year growth trend.

More RTVs Processed - A rise from 334 in 2023 to 408 in 2024, showing an increase in recorded incidents.

Logbook Entries Increased - 2,127 in 2024 compared to 1,848 in 2023, indicating more documented incidents.

Slight Decline in Operator Sessions - Down from 1,169 in 2023 to 1,089 in 2024, suggesting fewer shifts but longer working hours.

Top Crime Categories Remain Similar - Assault, theft, and criminal damage continue to be the leading offenses.

CCTV - GOOD WORK

Key Points from 30th November 2024

• General Observations

• Shops were proactive in reporting suspicious behaviour and theft, enabling quick responses.

Incidents and Responses

- 12:30: An intoxicated female attempting to open wine bottles was handled by ASB Wardens and BID Rangers and then handed over to ambulance services.
- 13:40: Male recovered £900 worth of electrical goods; pursued by ASB Wardens and BID Rangers but lost in the car park.
- 15:00/15:10: Three individuals recovered £142 worth of goods; fled to a car park and were captured on CCTV.
- Partnership and Coordination
- Effective coordination between CCTV, ASB Wardens, BID Rangers, and store security teams led to successful deterrence, recovery, and prevention of theft and antisocial behaviour.

Additional Reports

- 11th December 2024: ASB Wardens and CCTV detained suspects and recovered goods worth £127.
- **3rd January 2025**: Sierra 8 (Malting Security) assisted a person in distress in the Cheese Market.
- **11th January 2025:** Arrest of a wanted person, Mr. Gladding, in the Cheese market.
- 13th February 2025: A female attempted to smash windows of HSBC and other stores; arrested with CCTV footage used as evidence.



Count vs Day Of Week by AM or PM









Summary of 2024 Reports

- **Flytipping:** Throughout 2024, our Officers and Operatives have responded to 286 reports of fly tipping within the city, as well as assisting Wiltshire Council to combat this environmental crime.
- **Dog Fouling:** While incidents of dog fouling have only decreased slightly, it's still a widespread issue unfortunately, additional measures to combat this, from a dog poo bag dispenser, and an increase cleansing rounds have been introduced in high-traffic areas.
- Waste Disposal: Efforts to reduce unauthorised waste bags on the streets have shown success, with 158 fewer reports compared to 2023, aided by communication with businesses and residents.
- **Graffiti:** The team is tackling graffiti on a daily basis, helping keep the city looking clean and fresh.
- Broken Glass Since the introduction of the PSPO in May 2024, broken glass reports have decreased substantially in the city centre, indicating improvements in safety or cleanliness.
- Dublic Engagement: The public is encouraged to report various environmental issues such as littering, fly tipping, graffiti, dog fouling, vomit, and fly posting through the My Wilts App.
- Overall Improvement: The number of reports to Streetscene in 2024 decreased by 379 compared to the previous year, indicating a positive progress in the city's cleanliness.

January – February 2025

Street Litter and Cleansing: A decrease in street litter and flytipping in both January and February 2025 compared to 2024, indicates a positive shift in street cleanliness.








The graphs shown below detail the number of monthly reports received by our Streetscene Officers over the past year, either by the My Wilts App, through reports from staff or by residents through email and phone calls.

Key:

- Unlabelled bags mean any fly tipped bag of domestic waste dumped on the street without a authorised a white household waste label provided by Wiltshire Council
- Labelled bags mean they contain a Wiltshire Council white household waste label, but have missed collection and the resident hasn't arranged a rescheduled collection
- Fly tipping reports of the illegal act of dumping rubbish in a place where it is not permitted.
- Street litter and Cleansing covers reports of litter on the streets, dog foul, broken glass, human waste, vomiting, overflowing bins, trolleys left on the streets, flyposting, graffiti, obscene graffiti, dead animals, issues with play areas, issues with highways and pavements, vandalism or broken street furniture.
