1054 Chairman's Announcements:

The Chairman confirmed her attendance, with the Mayor, at the morning D-Day-80 event, along with the Mayor and fellow councillors at the evening event. The events were well received.

The Chairman highlighted that the new planters, outside the Guildhall, will need moving slightly for a Sunset Parade.

1055 Community Teams Update

The committee received an update presentation from Sarah Gregson, Head of Community Services, on the work undertaken and being planned for, by the Salisbury City Council Communities Team, this included (see this link: Communities Team update - June 2024):

 Additionally, Sarah Gregson was pleased to announce that following restructuring and successful recruitment campaigns the Communities Team are now fully staffed in all posts including Sam Johnson as Community Centres & Programme Manager. This will lead to resilience and consistency, including cover for leave, appropriate staff-to-client ratios, and enabling more

- community development from that team. A new team member has been recruited for Bemerton Heath Centre, which she already knows very well.
- Cllrs asked questions and Sarah Gregson confirmed the Bemerton Heath Centre has good community-wide use, although some days (particularly Fridays) have available space, with good uptake in classes and courses, including from those off-estate, which leads to feeling of community wellbeing.

 Cllrs commended the Community Services Team for this fantastic initiative.
 Lots of children are excited about it, and Safer Streets have been sharing around the city.

 - Cllrs highlighted a Football for Fatties scheme in Eastleigh, which includes advice on diet as well as fitness, and suggested this might be something SCC could consider in partnership with a football club, which Sarah Gregson agreed to look into.

 - Cllrs confirmed that they still signpost young people via schools.
- Safer and Supportive.
- Friary Young Artists Exhibition. Additionally, Sarah Gregson said that all
 participants received a year's free museum pass for themselves and their
 families; and the 5-Rivers exhibition space has been booked for later this
 year.
 - Cllrs commented that the art exhibition was excellent and suggested displaying somewhere, which Sarah Gregson is investigating.
- Summer 2024.
 - Cllrs would like to see more diversity of faith, backgrounds and communities at these events so everyone can learn from each other.

Clirs thanked Sarah Gregson and all the Communities Team staff for all their work and support and congratulated the team on being fully staffed. Both the young and older communities appreciate the projects and work.
