1. Report Summary

- 1.1. This report asks for the committee to consider new applications from local organisations to become a Salisbury City Lottery Good Cause.

2. Background

- 2.1. Salisbury City Community Lottery is a weekly lottery that raises money for good causes in the Salisbury City area. All good causes supported by the lottery will benefit the Salisbury City area and its residents. Details can be seen here <https://www.salisburycommunitylottery.co.uk/>
- 2.2. Salisbury City Community Lottery Good Causes must be operating or delivering a service within the City Boundary and for the demonstrable benefit of Salisbury City Residents
- 2.3. Eligible groups are Associations, Charities, Clubs, CIC's, Social Enterprises, Constituted Community Groups & Societies
- 2.4. Eligible good causes must have a bank account and two signatories.

3. Applications:

3.1.1. The Mayors Charity (Association)

- 3.1.1.1. This organisation is a community association raising funds and support for specific local causes, guided by the Mayor incumbent and specific to the City of Salisbury.
- 3.1.1.2. The Mayor's Charity fundraises for the Charity of the Mayor's choice for a number of personal reasons he has chosen the Wiltshire Air Ambulance
- 3.1.1.3. This cause has provided all the required information and meets all Salisbury City Community Lottery eligibility criteria.

3.1.1.4. The Broken Bridges Project (CIC)

- 3.1.1.5. The CIC focuses entirely of fundraising for the purpose of purchasing Broken Bridges (known as Fitzgerald farm). "So that we can bring the land into Community ownership and create a nature reserve for the people of Salisbury. We have an exciting opportunity to safeguard this much-loved natural area to restore and enhance its wildlife interest for everyone to enjoy and improve access for all."
- 3.1.1.6. The company is a CIC and meets all the eligibility criteria for the Salisbury City Community Lottery Good Causes
- 3.1.1.7. This cause has provided all the required information and meets all Salisbury City Community Lottery eligibility criteria.
