**Councillor Sven Hocking Environmental Working Group Update** 

We have:-

- Been given the accolade of most litter free city in England, so massive thank to SCC Environmental Services Team and our ID Verde partners and staff who have done a fantastic job all round.
- 2) We have reviewed the 34 points on our "Clean Street Strategy" the major items still on the table for which we are waiting a decision on are a) A-board policy b) abandoned shopping trolley's and c) presentation of commercial waste, the decision on which is still with WC
- 3) A much closer working relationship with the BID
- Winter Hanging Baskets are down and summer baskets are up and blooming well
- 5) Installed and officially opened the drinking water fountain in the Market Square
- 6) Painted all the railings, lamp posts, cut back the riverside vegetation and installed new street furniture on Riverside Walk
- 7) As part of SCC's £750K investment program in the City's public toilets, the Group has taken a decision on style, card/coin access, door colours and charging strategy for toilet cubicles for the coach station car park, construction of which will start in September / October
- 8) 2 x Speed indicator devices have been purchased and are due to make their presence felt in Harnham fairly shortly
- 9) Environmental Enforcement are still in operation two days a week
- 10)Our Venture Security Steward are out and about seven days a week, as examples of what they become involved in they played a major part in calming down the not inconsiderable problems happing under the Maltings car park a couple of weeks back, and worthy of special mention, is two of our chaps Ryan Tench and Darren Winter were recognised for their outstanding efforts in putting their personal safety on the line when dealing with a local man who was, armed with a scalpel, being very aggressive to members of the public in QE Gardens.
