

Temporary Road Closure Order Town Police Clauses Act 1847

IN ACCORDANCE with Section 21 of the Town Police Clauses Act 1847, which section gives Wiltshire Council ("the Council") the power to make an Order for roads within its administrative area to be closed temporarily to all vehicular traffic (and for alternative routes to be observed) for the purposes of preventing obstruction.

The Council HEREBY ORDERS

On: **Sunday 09th November 2025** between the hours of **09.00** and **14.00**

Purpose: **Remembrance Sunday Parade**

That the following roads and footpath in the City of **Salisbury** are to be closed (save in any case of emergency) to all traffic at the approximate times set out below:

Between the hours of 09.00 and 14.00:

- a) **Footpath 66, Salisbury (The Market Place)**; From its junction with Footpath 68 to its junction with Footpath 60.
- b) **Footpath 68, Salisbury**; From its junction with Footpath 66 to its junction with Butcher Row.

Between the hours of 10.30 and 11.45:

- c) **Avon Approach**; From its junction with Castle Street for its entire length.
- d) **Castle Street (Part)**; From its junction with Avon Approach to its junction with Blue Boar Row.
- e) **Blue Boar Row**; From its junction with Castle Street to its junction with Queen Street.
- f) **Queen Street**; From its junction with Blue Boar Row to its junction with New Canal.
- g) **New Canal**; From its junction with Queen Street to its junction with High Street.
- h) **High Street (Part)**; From its junction with New Canal to its junction with Bridge Street.
- i) **St. Thomas Square**; From its junction with Bridge Street to the access with The Parish Church of St. Thomas and St. Edmunds.
- j) **Bridge Street**; From its junction with High Street to its junction with Fisherton Street.
- k) **Fisherton Street (Part)**; From its junction with Bridge Street to its junction with Malthouse Lane.
- l) **Catherine Street**; From its junction with New Street to its junction with New Canal / Milford Street.
- m) **Milford Street**; From its junction with Catherine Street to its junction with Milford Hill.

And between the hours of 12:15 and 13:30:

- n) **Fisherton Street (Part)**; From its junction with Malthouse Lane to its junction with Bridge Street.
- o) **Bridge Street**; From its junction with Fisherton Street to its junction with High Street.
- p) **High Street (Part)**; From its junction with Bridge Street to its junction with New Canal.
- q) **Silver Street**; From its junction with High Street to its junction with Minster Street.
- r) **Minster Street**; From its junction with Silver Street its junction with Blue Boar Row.
- s) **Blue Boar Row**; From its junction with Minster Street to its junction with Queen Street.
- t) **Castle Street (Part)**; from its junction with Blue Boar Row to its junction with Chipper Lane.
- u) **New Canal**; From its junction with Queen Street to its junction with High Street.
- v) **Catherine Street**; From its junction with New Street to its junction with New Canal / Milford Street.
- w) **Milford Street**; From its junction with Catherine Street to its junction with Milford Hill.

Nothing in this Order shall prevent vehicles from proceeding in the said lengths of road when being used in connection with the event stated above.

Nothing in this Order shall apply to any person proceeding on the said length of footpath when acting in connection with the event stated above.
