All windows/exterior doors will be kept closed from 21:00 hrs except for the French doors at the rear of the property. The French doors no longer make up part of the licensed area.

The number of people on the first floor is restricted to a maximum of 60. The first floor shall no longer be part of the licensed area.

When the 04:30 close is to operate there will be no new entry to the premises after 2:30

On 04:30 closures 2 door supervisors will be deployed between 22:30 and 02:30 with 2 additional door supervisors between 02:30 and 04:30hrs.

When remaining open until 04:30hrs dispersal policy will operate 2 door supervisors inside ensuring patrons leave quietly and 2 door supervisors outside ensuring patrons disperse promptly. 2 door supervisors will be retained for 30 minutes after closure to ensure complete patron dispersal, if necessary the 2 door supervisors from inside when the premises has fully emptied will operate in Milford Street requesting customers who are loitering to make their way home.

When normal trading hours are in place 2 door supervisors will continue to be employed from 22:30hrs.
