The premises is to be an area opposite The Guildhall hall, on guildhall square, on the north side of the memorial. The space will be used seasonally, for a 6 week summer event, a 6 week winter event, and potential future various events on the guildhall square. The premises measures roughly 33m east to west on the square and 20m north to south in a rectangular share . The area is expected to house between 200-300 people during the busiest periods which will be controlled through the use of SIA licensed security during peak periods. Within the licensed area there is to be a bar with an upstairs stage, and a stretch tent for cover from the elements in the summer months, and a marquee type sytructure for the winter event . The site and will be retailing on-trade drinks only. There will also be a range seating, including accessible seating.

b) The prevention of crime and disorder

- Each Bar unit will have a personal licence holder
- All staff at bars will receive training in the retail sale of alcohol, this training will be recorded and refreshed regularly.
- SIA registered security staff will be employed at peak times
- This deployment will be informed within each event specific EMP
- No customers will be able to leave to the licenced area with open containers of alcohol
- Bottle bins will be appropriately secured and not publicly accessible.
- Columbia Events (The bar operator) will use a refusal register – this register will be through their electronic point of sale system.
- Each bar and point of entry will maintain an incident recording system. All incidents including crime and disorder will be properly recorded and, in enough detail, to allow for the identification of offenders where appropriate.
- Refusals and incident records will be made available to appropriate authorities on reasonable request as soon as practicable.

c) Public safety

- The Licenced area will have a maximum capacity of 500 people. This number includes all staff working in the licenced area.
- A full event management plan will be shared at least 28 days before each event.
 - The Event management plan will included (but not necessarily b limited to) Event safety inc medical provision, emergency plans, safeguarding of young and vulnerable persons and interoperability with emergency services.
- The event organiser will engage fully with the ESAG as necessary.

d) The prevention of public nuisance

- A noise management plan will be prepared to minimise noise nuisance to residents
 - It will be submitted to the licence authority no later than the associated event management plan for review by the Environmental Health officer
- Event lighting will be placed and appropriately shielded so as to minimise nuisance to local residents. It will not be used outside of licensable hours

e) The protection of children from harm

- A challenge 25 scheme will be implemented at all bars.
- Only recognised original forms of Photo ID will be accepted as proof of age e.g. driving licence, passport, military ID, Pass hologram



 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

Applicants must demonstrate that they have the right to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

They do this in one of two ways:

Home Office online right to work checking service.

As an alternative to providing a copy of original documents, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth, will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be shared digitally. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. 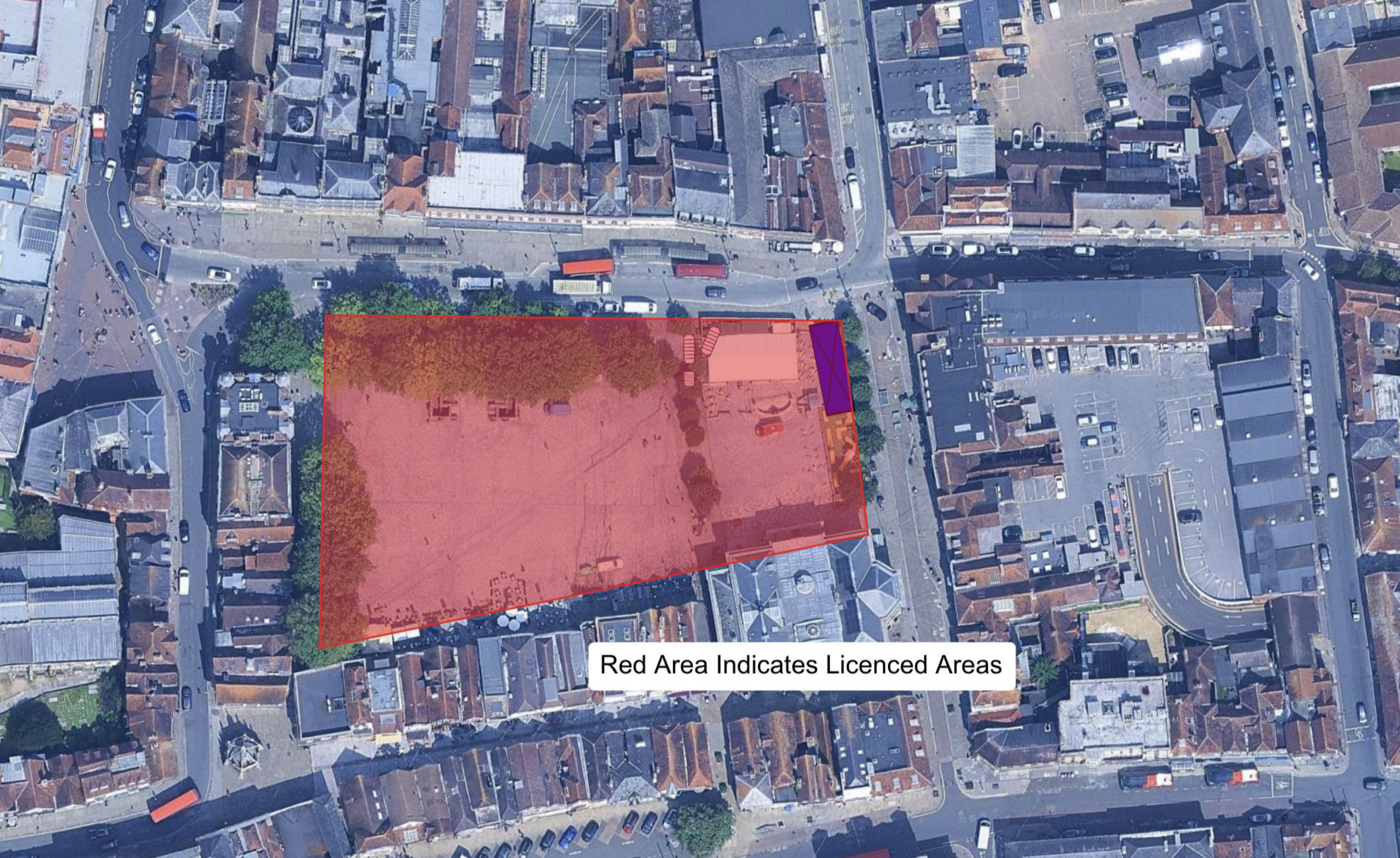

We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.
